**1. Grant of licenses or regulatory approvals:**

The Bureau of Indian Standards (National Standards Body, Govt. of India) has approved the grant of licenses to our Company under IS No. 398: PART 6: 2021, Registration No. CM\L 8400294317 and IS No.17505: PART1: 2021, Registration No. CM/L 8400294814.

**2. Capacity Reassessment:**

In continuation of our debottlenecking initiatives and incremental capex at the existing plant over the last 6 months, and as per the latest management assessment, the company's production capacity can now support a turnover of upto Rs.135 Crores per month, an increase from previous assessment of upto Rs.100 Crores. The utilization of the above revenue potential shall depend upon product mix, orders in hand and delivery schedules which vary from month to month.
